## Here's how it works:

1. Go to <https://wiki.clicklaw.bc.ca/>
2. Select the title you want from the list of Clicklaw Wikibook titles
3. Read the Wikibook! There are a variety of ways you can view these titles:
  - a) **Read online** - use the Table of Contents to navigate the Wikibook title and search for information
  - b) **PDF download** - download the full Wikibook title in PDF format. Suitable for viewing through a standard web browser or PDF viewer application such as Adobe Acrobat.
  - c) **EPUB e-reader** - download the full Wikibook title in ePUB format. Suitable for e-readers supporting the ePUB format (eg. The Kobo)
  - d) **Customize** - only need certain pages or chapters? Use this option to select the pages you need and create your own customized Wikibook
