COMMENTARY: Now that we have created a filter for British Columbia Pleadings, we can add our keywords to the search box. **Quotation marks** will allow us to search for wrongful dismissal as a complete phrase. An **exclamation mark** (or an asterisk) will allow us to find variations of a root word (eg. dishonest! will find dishonest and dishonesty). Lastly, the **AND** operator will allow us to find pleadings that have at least one reference to both wrongful dismissal and dishonesty.

COMMENTARY: Filters are located on the left-hand side of the search results page. In our example, we clicked on the dropdown menu for Legal Topics to find the filter for Employment Law. Having done so, our search results will only include pleadings that are relevant to employment law.
